## Certificate III in Individual Support (Ageing)

### Overview

This training is subsidised by the NSW Government under the Smart and Skilled initiative (eligibility criteria applies).

The program has been designed to meet an industry need for entry level workers in the aged care sector.

This accredited qualification reflects the role of workers in the community and / or residential setting who follow an individualised plan to provide person-centred support to people who may require support due to ageing.



Students will learn how to meet the personal support needs of the older person, support their independence and well-being, use safe working practices for direct care work, and will learn how to work effectively in the aged care sector.

The combination of classroom-based learning with work placement provides the foundations required to work with aged people.

During the program, students must complete a minimum of 120 hours of clinical placement providing direct care support in at least one aged care, home and community, or community services organisation. Students will practice their skills under supervision in an aged care facility. Placement will be organised by ET Australia and will allow the students to develop and consolidate skills and knowledge in a clinical environment. Placement also allows students to become familiar with employer expectations and broaden industry understanding. 100% attendance of placement in an aged care facility is required.

## Entry Requirements

There are no formal entry requirements for this qualification however all successful applicants will be required to undertake a criminal history check to meet workplace regulatory requirements.

The Australian Government Department of Health and Ageing requires that any person who provides care within an aged care service must have a police check prior to being present 'on site'. Students must not have previous convictions which would exclude them from working in the aged care sector as outlined in the Aged Care Act 1997 (murder, sexual assault, any other form of assault which has resulted in a sentence of imprisonment or any other conviction which would be considered, on the basis of risk and relevance, to render them unsuitable for a vocational placement in an aged care setting).

All applicants are required to complete an application form and must attend an interview for selection into the program. Interviews are conducted with each applicant to determine their suitability for the program and to ensure the program meets their career aspirations.

Aged care work can be emotionally and physically challenging and is very hands on. Applicants must have the functional capacity and fitness to perform the tasks and duties necessary to work in the aged care sector. Applicants who, due to fitness or functional capacity, would place themselves or others at risk of harm or injury would be unsuitable for the program.

Students must have the physical capability to be able to perform cardiopulmonary resuscitation (CPR) for 2 minutes on a manikin placed on the floor to meet the necessary criteria for the first aid unit of competency which is included in this program.

It is recommended that students have sound computer skills (as computers will be used on occasion during the program).

Applicants are required to have sufficient language, literacy and numeracy skills and it is recommended that applicants have good communication and interpersonal skills.

All applicants must be prepared to participate in work placement. Participation in a minimum of 120 hours of work placement is required to successfully complete the qualification.

In order to complete the practical components of this program applicants must demonstrate a level of maturity and discretion.

Students must be prepared to undertake learning and assessment activities outside of the scheduled face to face classroom training sessions. As a guide, students should expect to spend as many hours outside of the classroom as they do inside the classroom to complete additional learning and assessment activities.

Some of our partnering host work placement facilities require students to provide immunization documentation prior to being present on site. Given this, we request that at a minimum student have a flu vaccination and the commencement (at least) of Hepatitis B. These vaccinations / immunizations must occur prior to the first block of placement which occurs in week 6 of the program.

Please note, due to COVID-19 timetabled work placement blocks may need to be rescheduled depending on the instruction / advice of our host work placement organisations.

## Further Study

Students who successfully complete this qualification may choose to further their studies to a higher level in a related area such as CHC43015 Certificate IV in Ageing Support.

Students who successfully complete this qualification may also choose to further their studies at the same level and undertake units from the specialised elective unit streams available within the CHC33015 Certificate III in Individualised Support qualification e.g. Disability specialisation.

Students may elect to further their studies in more specialised qualifications at a higher AQF level from the Community Services Training Package.

## Structure

This program combines classroom-based sessions with work placement in an industry facility. On the job training is integrated throughout the duration of the program.

Students are required to participate **in all** scheduled classes unless arranged otherwise with an ET Australia Representative.

Students are required to complete a minimum of 120 hours of practical placement in an aged care setting. This is mandatory for successful completion of the qualification. The 120 hours will be achieved during the scheduled work placement blocks.

**Training Days:** Classroom days – Wednesdays, Thursdays  
(2 blocks of work placement will be integrated throughout the program)

**Dates:** 14 October – 13 May 2021 (there will be no training over the Christmas / New Year period – the last training day in 2020 will be Wednesday 16 December, with training resuming 13 January 2021)

Please note, if 120 hours of work placement hours aren't achieved during this training period, students will have the opportunity to continue the work placement to complete the remaining hours.

**Venue:** Young Parents Hub, 2A Amy Close, Wyong (for classroom-based sessions).  
**Please note,** The Young Parents Hub has an accredited childcare centre on site, Narnia Young Parents. Narnia Young Parents exists to provide a supportive partnership for parents who are studying at the Young Parents Hub.

## How will I be assessed, and do I need to complete activities outside of the classroom sessions?

A variety of assessment techniques will be used.

Students are required to attend all scheduled classes and participate in work placement for learning and the on the job assessment component of the program (a minimum of 120 hours of practical work placement is compulsory).

Students must successfully complete **all** assessment activities for each unit to achieve the qualification. Types of assessment activities include question and answer activities, case studies, simulations, workbook activities, projects and practical on the job activities.

Students are required to complete learning / assessment activities outside of classroom hours, the amount of time required will vary from student to student. As a general rule, the same amount of time spent in class should also be spent outside the classroom for study related activities. Your trainer will prescribe the additional activities for you, which will include revision, learning and preparation for assessment.

## Eligibility and Student Fees (Subsidised Training Place)

To be eligible for a Smart and Skilled subsidised training place, at the time of enrolment an individual must:

- Be an Australian citizen, a permanent Australian resident, a humanitarian visa holder or a New Zealand citizen, and
- Be aged 15 years or older, and
- Live or work in New South Wales, and
- No longer be at school or equivalent

If you're eligible for subsidised training under Smart and Skilled, you pay only a portion of the training cost.

If you're an Aboriginal or Torres Strait Islander person, a student with a disability or a Commonwealth welfare recipient, you and your dependants may be eligible for fee exemptions or concessions when enrolling. ### Smart and Skilled Fee-Free Scholarships

Fee-Free Scholarships are a category of 'fee exemption' meaning that recipients of a Fee-Free Scholarship are exempt from paying the student fee.

Smart and Skilled Fee-Free Scholarships are available for:

- Young people who are eligible for a concession fee
- Young people who are or have been in out-of-home care
- People who are experiencing or have experienced domestic and family violence and their dependants

### Are you eligible?

To be eligible for a Fee-Free Scholarship students must:

- meet the Smart and Skilled eligibility criteria.

AND

- be aged between 15 and 30 years when you start training; and
- be either the recipient of a specific Australian Government welfare benefit or allowance or the dependant of such a recipient (please refer to the fact sheet **Smart and Skilled Fee-Free Scholarships – For concession-eligible students** below for further details as to eligibility); or
- be aged 15-17 years and currently in out-of-home care or aged 18-30 years and previously have been in out-of-home care (please refer to the fact sheet **Smart and Skilled Fee-Free Scholarships - For young people in out-of-home care** below for further details as to eligibility)

OR

- be aged 15 years or over and have a letter of recommendation from a domestic and family violence service, refuge or other support agency (please refer to the fact sheet **Smart and Skilled Fee-Free Scholarships – For people who are experiencing or have experienced domestic and family violence** below for further details as to eligibility and information about organisations which can provide the letter).

## Attachment 1 - Fee exemptions and concessions

Students who qualify for a **fee exemption** are:

- Australian Aboriginal or Torres Strait Islander people
- People with a disability (ie people who meet the disability fee exemption criteria, including the dependent child, spouse or partner of a recipient of a Disability Support Pension).
- Recipients of Fee-Free Scholarships

A student who receives a specified Commonwealth benefit or allowance is eligible for a **concession fee** for a qualification up to and including a Certificate IV. A student who is receiving an eligible benefit or allowance at the time of enrolment is eligible for a concession.

The concession fee is also available to a student who is a dependant of a person receiving a specific Commonwealth benefit or allowance. To be eligible for the concession the person who the student is a dependant of must be receiving the benefit or allowance at the time of enrolment.

The specified Commonwealth benefits and allowances for concession fees include:

- Age Pension
- Austudy
- Carer Payment (this category does not include the Carer Allowance or Carer Adjustment Payment)
- Disability Support Pension
- Family Tax Benefit Part A (maximum rate)
- Farm Household Allowance
- JobSeeker Payment
- Parenting Payment (Single)
- Special Benefit
- Veterans' Children Education Scheme
- Veterans' Affairs Pensions
- Widow Allowance
- Youth Allowance
