We are really excited to offer an evening aged care program. This unique fee-free* program, delivered onsite at Killarney Court, Killarney Vale, has been designed to meet Alino Living's need for entry level care support staff.

Alino Living is home to five residential aged care communities located across the Central Coast in Killarney Vale, Lake Haven, Wyoming and Norah Head. Delivering a brighter future for hundreds of residents and team members, Adelene Court, Killarney Court, Rumbalara House, Lake Haven Court and Central Coast Community Care Association and Vietnam Veterans KPVC have merged to become one organisation. Alino Living is one of the largest independent not-for-profit aged care organisations on the Central Coast of NSW.

The classroom component of this employment program will be delivered onsite in their Killarney Court facility. The work placement component will be hosted by the Alino Living facilities, providing hands on training with a view to employment as a Care Support Worker with the organisation.

ET Australia and Alino Living share a vision for how the entry-level workforce needs to be prepared and trained. This has resulted in a collaborative partnership between the two organisations.

To be considered for employment with Alino Living, students must participate in a CHC33015 Certificate III in Individual Support (Ageing) training program. There will be opportunities for employment with Alino Living for the best suited students. There is the possibility that employment offers will be made prior to the completion of the program.

This is a fantastic opportunity to become part of the Alino Living team. The program allows both the organisation and the student to make a well-informed decision about any offer of employment.

Students will learn how to meet the personal support needs of the older person, support their independence and well-being whilst using safe working practices for direct care work.

Alino Living's policies and procedures will be embedded into the training to prepare the students for 120 hours of work placement.

The combination of classroom-based learning with work placement provides the foundations required to work with aged people.

Entry Requirements

There are no formal education requirements for this qualification however, all successful applicants will be required to:

Undertake a criminal history check

The Australian Government Department of Health and Ageing requires that any person who provides care within an aged care service must have a police check prior to being present 'on site'. Students must not have previous convictions which would exclude them from working in the aged care sector as outlined in the Aged Care Act 1997 (murder, sexual assault, any other form of assault which has resulted in a sentence of imprisonment or any other conviction which would be considered, on the basis of risk and relevance, to render them unsuitable for a vocational placement in an aged care setting). Please note, if a student has any outcome/s at all appearing on their criminal history check, ET Australia must seek approval from the host work placement organisation for the student to participate in work placement. ET Australia approaches cases such as this with sensitivity and the identity of the student is not disclosed during this process.

Formally apply

All applicants are required to complete an application form, participate in an information session and an interview for selection into the program. Interviews are conducted with each applicant to determine their suitability for the program and to ensure the program meets their career aspirations.

Physical attributes

Functional capacity and fitness to perform the tasks and duties necessary to work in the aged care sector including physical capability to perform CPR for 2 minutes on a mannequin placed on the floor. Applicants who, due to fitness or functional capacity, would place themselves or others at risk of harm or injury would be unsuitable for the program.

Digital skills

Sound digital skills are needed as students will be required to undertake activities such as using the internet to conduct research, send / receive emails (all of which can be done using a smart phone).

Language, literacy and numeracy

Sound language, literacy and numeracy skills are required and it is recommended that applicants have good communication and interpersonal skills.

Provide evidence of vaccination

Students will need to provide immunization documentation prior to program commencement. At a minimum student are required to have a current influenza vaccination, plus students must provide evidence of having had 3 doses of a COVID-19 vaccine as per the Public Health Order (COVID-19 Care Services) No. 2, 2022. https://www.health.nsw.gov.au/Infectious/covid-19/Pages/racf-latest-advice.aspx

In order to complete the practical components of this program, applicants must demonstrate a level of maturity and discretion.

Employment Opportunities

The purpose of this program is to assist Alino Living with their recruitment of entry level staff. Alino Living intends to employ suitable candidates from the program as Care Support Workers. Offers of employment will be made to students who display the qualities and attributes they are looking for in entry level staff.

Other examples of employment opportunities include Accommodation Support Worker, Assistant in Nursing, Care Assistant / Worker, Care Service Employees, Nursing Assistant, Personal Care Assistant, Residential Care Worker.



Students who successfully complete this qualification may choose to further their studies;

- Higher level study in a related area such as CHC43015 Certificate IV in Ageing Support.
- CHC33015 Certificate III in Individualised Support e.g. Disability or Home and Community specialisations.
- Specialised qualifications at a higher AQF level from the Community Services Training Package.



Training Structure

This program combines evening classroom-based sessions with 2 work placement blocks integrated throughout the duration of the program.

Students are required to participate in all scheduled classes unless arranged otherwise with an ET Australia Representative.

Students are required to complete a minimum of 120 hours of work placement. This is mandatory for successful completion of the qualification. The 120 hours will be achieved during the scheduled work placement blocks.

Schedule and Venue

Sessions:	Classroom sessions - Tuesday and Thursday evenings (Work placement dates / times will be scheduled with each student taking into consideration their commitments. At a minimum during the scheduled blocks of placement students are expected to participate in 2 work placement shifts per week which can include day, afternoon or evening shifts. PLEASE NOTE, Shift times will be aligned to the shift times of the facility).
Dates:	10 October 2023 – 23 May 2024 (There will be no training over the Christmas / New year period – the last training date in 2023 will be 14 December, and the first training date in 2024 will be 9 January).
Venue:	Classroom (Killarney Court Aged Care, Corner Cornish Avenue and Wyong Road, Killarney Vale). Work placement – will be hosted within Alino Living's facilities on the Central Coast; • Killarney Court, Killarney Vale • Lake Haven Court Aged Care, Charmhaven • Vietnam Veterans Hostel, Noraville • Adelene, Wyoming
Classroom Times:	5.00pm to 9.00pm (except for first aid training which is offered of a day from 9.00am to 4.00pm and during work placement when times will align to shifts within the facility)

Assessments

A variety of assessment techniques will be used.

Students are required to attend all scheduled classes and participate in work placement for learning and the on-the-job assessment component of the program (a minimum of 120 hours of work placement is compulsory).

Students must successfully complete all assessment activities for each unit to achieve the qualification. Types of assessment activities include question and answer activities, case studies, simulations, workbook activities, projects and practical on the job activities.

Students are required to complete learning / assessment activities outside of classroom hours, the amount of time required will vary from student to student. As a general rule, the same amount of time spent in class should also be spent outside the classroom. Your trainer will prescribe additional activities for you, which will include revision, learning and preparation for assessment.

Eligibility

This program is fee free* (\$0) for people who meet the Smart and Skilled eligibility criteria outlined below.

To be eligible for a Smart and Skilled subsidised training place, at the time of enrolment, an individual must:

- Be an Australian citizen, a permanent Australian resident, a humanitarian visa holder or a New Zealand citizen, and
- Be aged 15 years or older, and
- · Live or work in New South Wales, and
- No longer be at school or equivalent

*Training in priority qualifications is fee-free and fully funded by the NSW and Commonwealth Governments.



ET Australia has a dedicated Training Officer for each training program. The Training Officer works closely with all students throughout the training period. In addition, students have additional access to the Trainer/Assessor, above and beyond the classroom hours. 
